WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the Lioness Club of Central Square's Bunny Hop Craft and Vendor Show ("the Event") on March 10th, 2018, I hereby release, waive, discharge and covenant not to sue the Lioness Club of Central Square, the Lions Club of Central Square, Lions International, and Brewerton Fire Department, or any property owner that may allow us to use their premises or equipment, or any of their officers, members, servants, agents and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the Event, or while in, on or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event. If I am signing this on behalf of an organization, I attest that I have authority to do so, and agree that my signature covers all persons involved with the festival on our behalf.
2. I am fully aware of risks and hazards connected with being on the premises and participating in the Event, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Event, and I hereby elect to voluntarily participate in the Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Event, whether caused by the negligence of releasees or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs, including reasonable attorneys fees and expenses they may incur due to my participation in the Event, whether caused by the negligence of any or all of the releasees, or otherwise.
4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named releasees. In signing this release, I acknowledge and represent that:
 - A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
 - B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
 - C. I am at least eighteen (18) years of age and fully competent; and
 - D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

Location: Brewerton Fire Department 9625 Brewerton Rd, Brewerton, NY 13029. From Route 81, take Exit 31, turn right on Bartel Rd, go to traffic light and turn right onto Route 11 N and you will see the Fire Department on the left side of the street.

Date: 3/10/18 9 am – 4 pm.

Credit Cards: We have the capability to accept credit cards online for application fees.

Online Applications Available: You can fill in and send your application and payment electronically from our website. A convenience fee will be applied to all online payments.

Set Up: Crafters and Vendors may set up on the day of the event between 7:30 am and 9 am. Please check in at the registration area to be directed to your space.

Additionally, please remember the following:

- There is no electricity available.
- Participants must provide any equipment needed to set up their space.
- A limited amount of tables are available for rental, but you must reserve them on your application.
- All vendors must follow all rules and requests of the committee.
- No raffles or free drawings are allowed unless specifically approved by the committee prior to the festival.

Crafter and Vendor Spaces: Spaces are approximately 8'w x 6'd, at a cost of \$40. Tables may be rented for \$10 each while supplies last. The application deadline is 2/25/18..

Crafters and Vendors that wish to donate to our vendor raffle, please drop off your item at the vendor registration table when you enter.

Bad Check Fees: Any check returned unpaid from a bank will be charged an additional \$25 fee Parking: You may park in front of the building to unload your vehicle, but please park your vehicle prior to setting up your space to allow others to unload.

Insurance: All vendors are encouraged to provide their own insurance, if desired. We can not be responsible for losses. Vendors with insurance are asked to submit a copy of their insurance naming the following as additional insured: Lioness Club of Central Square and parent organizations and Brewerton Fire Department. Please contact us if your insurance charges to add additional insured.

Hold Harmless: All participants must sign and submit the Hold Harmless Agreement with the application.

Restrictions: No religious or political solicitation is allowed. No raffles are allowed.

Cleanup: All vendors are responsible for cleaning up their own areas after the event. Garbage must be removed from the premises.
